▲ Our universe, existence, everything around us we call nature. Change is the basic operation of nature. Everything we can see and touch is subject to constant change. Some change is directly perceptible (wind, heat, sounds, light). Other change can only be perceived due to the differentiation of before and after, i.e. by referring to the previous state in memory. Dignity - Without definition, every belief and opinion is right

The dignity of the human being

So far, the concept of dignity could only be circumscribed. In general, it is defined by linking it to the definition of "Dasein" – Greek "zoe", life. I.e. the actual sense means accordingly that life, around whose dignity it concerns here, can as far as possible in full extent its given abilities in and convert.

The dignity - must be understood

To be able to express this understandingly, it needs an understanding of life. Until now, this understanding could not be completely specified, i.e. it could not be described exactly. Most different subjective opinions and corresponding procedures shaped the understanding of life so far.









In 2020/21, the word social was known, as was human dignity.

However, this was completely misunderstood until then, on the world conditions prevailed as never before.

On the one hand, there were technologies and possibilities that would have made it possible, without really taking anything away from anyone, that all people could have lived in dignity, the living space could have been shared.

The following numbers are known approximately: There were about 82 million refugees due to wars,



about 30 million people die of hunger, 155 million people suffer from hunger, extreme poverty 745 million people, natural disasters and damage as neverbefore since people remember.

On the other hand, so much money and wealth as neverbefore.

At the same time, however, as many mentally ill as never before, drug use as high as never before.

No animal species on earth is known to behave as anti-socially ashumans.





The dignity - to this day opinion, belief and lack of understanding

Dignity was previously measured in quantity.

In reality, the dignity of man was tied to the fact that man has corresponding necessities of life, basics such as sleeping accommodation, food, etc., at his disposal. An understanding about temporal processes, their exact influence on the human being, i.e. the function of those, could not be factually specified until now.

The opinions, the belief what life is

For this reason there are most different opinions and procedures with which in the past one tried to tune humans in relation to its function and needs as well as possible. That this can degenerate again to problems, differences of opinion as well as quarrel up to the war, is generally known. Quality of life could not be expressed in any way so far.

No commonality, understanding

Until now, it was unthinkable that there could be a universally valid understanding that could precisely clarify the function and needs of humans despite their individuality. That this exists, however, is neither surprising nor surprising.

The lack of understanding towards nature

Until the end of the millennium, the opinion was still widespread in some cultural areas that there could be something other than logical connections. Since every perception, every change represents a logical temporal connection, thus an interaction, whether this is visible or not, we know already longer. That also every thought originates from a physical logic, the physical interactions which take place in the brain, we know likewise. The processes how it exactly happens that a thought is addressed or a feeling occurs, however, were not yet completely logically generally validly explained up to now.

■ The dignity – understanding is the key

We can now understand

On the basis of the discovery of the logicaloperational axioms of existence, the dignity of man can now be defined universally for every individual. This has a considerable effect on the future of mankind as a whole. A general logically clearly comprehensible definition makes on the one hand a context and competence independent explanation possible, which can be made understandable within short time for each humans, from which a common generally valid understanding of itself, its identity and of other humans develops. As a result, wars of belief and opinion and disputes will soon be a thing of the past.

It will have a positive impact on life

Moreover, this will have a serious impact on general legislation, since in constitutions that guarantee human rights or human dignity, as in Germany, general laws will have to be corrected and adapted due to a lack of precision or erroneous assumptions.





The dignity – the right expression

New understanding of words and concepts

Many terms like intelligence, ethics and morality will be redefined or will get a clear precise meaning. As one of the most important effects, a universally valid definition and understanding of ethics, morality, and thereby a precise definition of justice will be made possible and will eliminate countless misunderstandings and differences of opinion.

Understandinglife

In order to be able to make a generally valid definition of the "dignity of man", an understanding of life itself is needed. This is new and could not be specified in this way in the past.

Autonomy – Understanding

The understanding of life, especially of autonomous organisms like humans is elementary.

An autonomous life like a human being is only able to survive...

- 1. on the basis of an environment,
- 2. by certain abilities,
- 3. by the use of these.

Explanation of axiom pairs

The basis of the system is in each case a pair of interactions, i.e. an operational logic, a pair of axioms consisting of 1. an order and 2. an operation.





The dignity – logic of nature

Order, the order of nature

The order is thereby the basis on which any effect functions, the operation the security that any effect is also actually executed on basis of the order. I.e. the order is that which is applied logically concluding or retracing, in order to be able to represent the effect logically in advance (projection) or in retrospect (inference). This is a logical operation and not a mathematical calculation.

Operation – an endless interaction

An operational basic logic is always context- and competence-independent. It can be applied in any context by any competence (autonomous organism, electronic logical calculation system like Actionstep), which has the understanding of the operational basic logic to any situation, any context. This is the basis of the function of the brain of humans and animals.

Effect description Operation & order of a pair of axioms

The order expresses thereby the interaction of something, the operation – which is infinitely continuously – thus as long as the object exists on another object reciprocally (cooperative) logically with each other combined (balanced). This logic is an operational circle, contrary to the assumption a circle referring to itself (Perpetual motion machine) is not functional, this circle has 4 components, 1. the order, which is constant unchangeable, 2. the operation, which realizes the order with an operation, the mutual effect cooperative, 3. the "something" or object, which is the content of the operation, to which the order is applied – balanced 4. N times other contents/objects, which interact mutually balanced cooperative.





■ The dignity – quality and logic

This level is below quantification and identification of objects

This logical explanation is below the physical and mathematical laws, because it is not dependent on space, time, competence or context and therefore can be used without restriction. (Details in "the secret of existence").

Operational logic and arguments

Operational logic does not know any knowns, i.e. operational logic does not need any named or known arguments, i.e. it does not need a previously acquired competence, but exclusively the logical competence and can deal with it simply because it is there, in and with every environment, i.e. explore the bases by logical inferring operation and deal with it. I.e. the basis is always the logical inferring operations such as: reasoning, inference (into the future, projection), inference (experience), reverse inference (responsibility) based on the general logic according to Balanced Cooperative Operational Logic.

Operational means that an operation or function is given, i.e. it is described in execution. This means that if an operational logic is fulfilled (i.e. all elements contained in the logic are present), this automatically comes into execution. Operational logic is always based on the basic logic of nature, and always contains at least two semicircles (which result in a natural cycle, such as day and night, charging and discharging), which interact or interact with each other according to BCOL. Accordingly, an operationallogic is not a law, but a principle of operation.





Dignity - operational logic teaches us how to handle

Operational logic, ist components

This operational logic is distinguished by its components1. order, 2. operation, 3. content, 4. the balanced cooperative interaction. Accordingly, it is the basis of the existence of time and space. This makes clear: Every thinking, that this logic could be changed in any form or could be bypassed, is erroneous. Within the existence everything uses as basis this logic, otherwise it would not be existent. So there can be no further or other explanation, because this would dissolve the existence. Operational logic itself cannot be calculated like mathematics. It is compared, combined, differentiated, concatenated, isolated, inferred, projected, verified in logical procedures. The peculiarity of the operational logic bound to nature is that this always has interactions, i.e. everything is a process.

What is special about operational logic

Logically everything is known and can be understood with it. Logic understands everything and can deal with everything.

Dealing with the unknown

There are no unknowns in logic. The logical principles of our existence are: 1. nothing, 2. something, 3. something else, 4. the effect as interaction, the fundamental order, the time as operation. In a "nothing" unknowns are called something and something else. Something and something else act on each other. If one finds no change (operation), this means, the state of entropy has occurred. As long as there is life, this cannot be the case, as long as emergence is valid, the situation, the context is always starting point for the next context, the next situation, this infinitely continuously.





Dignity - absolute accuracy, the endless operation

■ Logical absolute accuracy, situational accuracy A logical prediction about a single logical ordering and operation set does not need any accuracy and is accordingly to be quantified as absolutely exact, as long as he represents a basic logic thus an operational logic, this does not quantify. That means, the logic is absolutely exact, because if something and something else are determined, a difference results.

Differences – the change

This difference is the logical interaction of the moment. This procedure is known among other things also under triangulation or mathematical 3– set solution, which indicates the state, the state of the entropy. Temporal interaction, that is the operation of logic arises by making exactly the same differentiation of "something and something else" at one moment, the result is differentiated again with the previous one.

The change in time the mode of action

From this results the temporal mode of action of the interaction. If there results no sine, circle or the section of a circle – operational logic is a circle reference and must always be closing – this means the logical conclusion that there must be something else besides something and something else again which exerts an interaction.

This is actually quite logical and a procedure of observation, already used by every human being manytimes.





Dignity - The reliability of logic

Reliability of logic, of time

Since the time, the thought or the interpretation of it is derived on the basis of the operational logic of the sun, rhythm day and night, afterwards interaction of cogwheels or atomic decay, the time is relative. It is dependent according to the emergence of the context and is a competence on a certain context, thus a clock with gears, sundial or atomic decay.

Theattempttocountthetime

A seemingly constantly visible operational logic is used and the time does not indicate anything further, after how many operation-interaction-cycles a similar emergent state is to be observed again. Thus a mathematical counting rhythm. If the contexts, i.e. the interactions, which influence the cyclic repetition change, the time changes accordingly at this place too, without this being noticeable under certain circumstances. The operational logic did not change thereby, it remains reliable and is unchangeable. The order of the operational logic is unchangeable, the interactions change, this is called emergence.





Dignity - order of the principle

Order - the principle of operational logic

Operational logic is always a system of order, an order according to which everything is logically built up, an operation which proceeds unchangeably, irrevocably infinitely continuously according to this order. It is reliable, infinitely continuously observable as energy, does not get lost (law of conservation of energy), the result in the 2nd thermodynamic theorem is called entropy. However, the results of this are variable, called entropy. That means, for us perceptible it may look as disorder, but in fact it is a holistic, unchangeable order, by which all existence becomes existence at all, a balanced cooperative system. The more exactly we look, the better we will also see this order. However, it is of temporal nature.

■ No atom shears out of this order, but very well we can produce any "disorder" also among atoms. However, it will be transferred again – even if it takes eternity according to our calculation of time – into an appropriate order. This understanding is important because this order is the most important maintaining system of the existence, the basis of the existence.





Dignity - Every natural system is logical

Order systems – logical connections

On the basis of the order and the interaction, i.e. the operation, its order and security, something and something else close together or repel from each other. The relation of the interactions is responsible for it. In general, everything is subject to a same system, but since something the same cannot exist, everything interacts with each other, there is an effect of one on the other. (It is not yet completely described how the first something came about – the Big Bang, this is at the moment the valid idea, which can still change, but will have no influence on any of the following ideas, because the fact of the operation cannot be doubted). In the model assuming that an effect due to interaction is nothing more than a movement, this due to the interaction within "nothing" in interaction to something, something will move, something else will interact and move either opposite or equal and thus represent an infinitely continuing oscillating system. It is to be considered thereby that on something and something else, since this happens in nothing, also nothing can act further and there are no braking effects, thus no interactions, which can slow down this system. Entropy means nothing more than that everything oscillates in the same relation to each other.

■ If one thinks of this now with particles with many single oscillations, many again independent, seemingly closed, stable systems can form within the total system (compare atoms and their function or our universe).

Dignity – Emergence determines the world

Emergent modes of action

The infinitely continuous operation, the interactions on each other, can become visible in two ways: countercyclically or co-cyclically. Co-cyclic is a composite operation, imaginable as magnet or gear wheel (attracting resp. interlocking). That means, the interaction on each other is like a entrainment of 2 something. It fits together. The opposite effect would be opposite, i.e. it does not fit together and keeps itself accordingly at a distance, it fits thus again together that it finds in each case its own adjacent place and works thus. All effects are balanced cooperative. (These explanations are still written with further models and ideas and more precise texts, this is further scientific work). To the difference of the perception the logic of the cohesion of logical systems is not to be explained by force and weight, that is like everything else only the result of the logical operation and perceptible within the existence. In fact, however, owed to the logical procedures of interaction. Only the resulting systems and known chemical elements or compositions are accessible to our direct perception. The logical operation describes accordingly how these come about and that we can perceive them at all.





Dignity – Every existence carries power

The logical interaction – the power of existence The logical interaction, the quantity of the interactions, results in the mass. The more inconspicuous an interaction seems to be for our perception, the more important it is for the existence. To the understanding: the interaction among atoms is apparently not perceptible to us and therefore apparently also not of importance. In fact, this is the other way round, not the big result is important, but the almost infinitely many and infinitely continuous operational interactions in the smallest. These are the cohesion (composite, attraction) or the distance (opposite, repulsion) of the only possible resulting complex systems like chemical elements, planets and the interaction system of the universe. To facilitate the imagination: without somehow evidently material (thus a complex system, which we can touch) with appropriate energy is shifted, we use a cable, through which electrons flow (interaction systems, smallest interactions), which can move however largest systems with appropriate force development. Or an atomic bomb, in which alone 5kg of a certain material put itself by smallest interactions into a condition that interactions in it react with an opposite process (thus from each other repelling), so that we perceive this as almost infinite force or energy. That means, these small however very fast interactions have an improbable effective power, are the power of the cohesion of the universe, of the existence. The logical conception is therefore opposite to our perceptive conception exactly: not the big is the energy and the power, but the small is the energy and the power, the big only the effect of the small.





Dignity – Every circle must be closed in order to function permanently

Logical systems interacting with each other

Logically in itself interacting systems are known to us as so-called particles, electrons, atoms, quanta, light and so on. Logically, there are neither particles nor atoms. There are exclusively interactions and systems which unite to each other due to composite action. If the unification is not exactly composite, this is balanced by another composite or opposite system. I.e. operational logic always consists of several components which interact, so that their function forms a circle. A closed circle forms again the starting point for the next effect. A not closing circle means therefore, there must be still another interaction, over which the circle closes. Only the closed logic results in the logical conclusion and the possibility of existence, makes order and operation possible. On the basis of this logic new explanations and technologies can be developed in the future, which operate in contrast to today's technologies changing the cycles of nature balanced cooperative either as composite or opposite procedure or alternating oscillating harmoniously under use of nature.





Dignity - compensation, the operation of circuits

■ Logical large-scale systems - closed systems for us, elements

Chemical elements are for us corresponding "large systems", i.e. they consist of interactions which contain composite and opposite effect, however, in the closed circuit of the total effect of the existence for us as material perceptible and manageable. In contrast to e.g. electric current, which is perceptible for us as energy. Thereby in for us visible and perceptible material the main interaction, what we would call physically energy, is the effect that the material holds together for itself and accordingly as system "material" shows an outwardly "only" total imbalance compared with the total cycle of the existential interactions. I.e. the main energy is used balanced to hold together. This cohesion results in chemical elements and material connections. This explanation will be worked on in the future to make it more precise and express it. An element is thus a seemingly static emergence of interactions within that appear to be stable within a given situation relative to other elements. Perceivable to humans as stable in time, seemingly not changing.





Dignity - Everything interlocks

directinteractions

If one starts logically from something which has an interaction with something else, then it is always the case that something and the other something affect each other in their relationship. Both are changed, they change their position. If there is still something else, this is seized just the same again by interactions and affects thereby everything else. So it is a whole structure which works with each other. Within this structure, individual interactions can be attractive or repulsive to each other (composite or opposite), this depends on their environment and the individual effect of everything on the individual. Something that acts uniformly with the other (harmonizes), can be together with it in a close community. This creates systems of effects. That means, these systems are stable for themselves in the total effect of all others and hold themselves together by their own internal effects. Atoms or chemical elements are called this. This gives rise to combined large elements, because the chemical systems can in turn interact with other chemical systems and here again form communities stable in their properties. These are then compound chemical elements, they use each other and combine, thus forming a stable community. By changing external physical modes of action, such as pressure, temperature, elements can thus be combined or extracted. CO2 and H2O are well known compounds of this kind.





Dignity - Biology and Physics

The compound of elements

Elements can be put together in such a way that they form a completely own logical community, not only use the direct interactions, but also indirect interactions, because whenever elements change, indirect interactions arise, which we can perceive as sounds, heat or light. These are so slow, the changes take so much time, that we cannot perceive them as solids, although in the air they can very well cause interactions and also some pressure by change resistance or when hitting bodies. Even light can cause pressure, e.g. today it is possible with lasers to lift objects. These slow interactions in time, so like e.g. light and liquid elements, can be converted by logical composition of elements, to so called biological machines. I.e. biological cells are formed, which can build themselves with the help of the energy of light (these are free oscillations, which do not work in the solids) and heat. This is called logical-operational process. Biological organisms are formed, which use the effect of interaction within several interactions over time for their own continuance and reproduction.





3. Autonomous Life The human being Its life and interaction with nature





Dignity - Standstill is an illusion

Logical interaction – the perception of time and understanding

We perceive interactions as a sequence. A sequence always takes place within time. But since everything is always in motion in nature, we see ourselves as not in motion and the other as in motion. This is our relative viewing error. We humans are not constant, but we perceive this by physical interaction.

All perception is stored by our Blueprint logic in physical connections and cells in our brain. I.e. our consciousness and our interpretation is in a constant change, which we cannot notice at all, because we are the center of the change.

■ Therefore, we cannot perceive these changes directly, but only as an understanding. However, since this is the basis of our brain of the Blueprint logic and nature, it is all the more important that we understand this for an understanding contact with us and nature. Understanding is a logic, a process, which is completely abstracted from situation and things and therefore can be adapted again into every situation and with everything.





Dignity - perception as a bridge between me and the world

Logical interactions – change

In our perception we have a differentiated logic of how we perceive our environment through our sensors (like eyes, ears) and also our actuators (like hands, feet).

■ This perception comes from the interactions of the sensors like actuators with other. When we grasp an object with our hands and lift it, we become aware of this interaction.

Through our hands, the kinetic energy, we can put this object in another place or lift it in the air.

Our brain – the Blueprint logic – is responsible for the fact that we have these abilities at all. Eyes alone as sensors and hands as actuators would never beco– me active on their own to either look at or grasp an object specifically.





Dignity - sensors, interaction with the inner world of human beings

■ Logical implementation through sensors. In order to be able to see or grasp anything at all physically, the tools must be available that make it possible to bring about a corresponding interaction.

■ This means that the eye itself can interact with an object, but it would never focus an object by itself. For it to be able to focus an object at all, further interactions, such as eye alignment, lens alignment, etc., must first be carried out in the eye.

Only when the main interaction is directed only to the object to be focused and this actually then shows the main interaction by in this case the radiated or the missing radiation of light, the object becomes perceptible for the eye.





Dignity - the eye as an actuator

■ If you dissect the sensor eye, you will notice that the eye is not really only a sensor, but also an actuator.

Since, on the one hand, a focused function is only possible through actions such as alignment, lens adjustment, etc., and on the other hand, the actual "seeing" is also an interaction with an object.

Only that in this case the object is not noticeable to us, but interacts with us as a matter of course through the interaction of the light ■ From our point of view, we do not use a force (energy) to interact with something, but the force or energy, called in balanced cooperative living interaction, comes from the object itself.

For the ease of imagination:

If we had to spend force (energy) to be able to see an object, we would interpret this in our conscious perception completely differently. And nevertheless, with night we need strength (energy), since we cannot produce this however ourselves, we have created ourselves the aid light, lamp, in order to be able to realize this interaction eye-object also in the night.





Dignity - actuators, unconscious power

The logical skill, actuators

Actuators, in our conscious thinking, are hands, feet, anything that can directly interact with other objects that offer some "tangible" resistance.

■ With our hands, for example, we can grasp a cup and bring it to our mouth. As an adult, we don't think much about this. Only when this no longer works, e.g. due to illness, do we realize that this is not a matter of course. The hand is still there, but the cup can no longer be grasped, because Parkinson's disease, for example, causes the hand to tremble. Even this process is not possible for a baby or toddler, who may be able to touch the cup, but cannot grip it perfectly, does not hold it straight and spills accordingly.

■ The process of grasping is accordingly complex – or better expressed a concatenation of many logical actions. These actions are not made by our hand, they are controlled by our brain, the blueprint logic.





Dignity - the brain, infinitely logical power

■ In normal adulthood in such a way that we do not consciously notice them at all, because our brain provides them to us automatically. Yet our brain has many small logical parts that it connects in nanoseconds, controlling the sensors and actuators in a verification system.

■ The brain knows before it even acts which result will come out. This is due to the Blueprint logic, which can adapt a future prediction on the basis of previously abstracted logical experience at any time arbitrarily into each situation and thus for us the ability of perception and purposeful action arises at all. (Read the books "Consciousness", and "Intuition"). At baby age we are still consciously training ourselves to lift a ball, throw it, grab the cup until this is built up in our brain, i.e. the blueprint logic has created the appropriate cells and connections.

■ The automomous organism automatically turns to new tasks, it is its endeavor – the curiosity to experience new things, because that is the purpose of life, the task of the brain and the Blueprint logic.





Dignity - brain, any path is logical

■ The Blueprint logic – the logical path system After the functioning of thinking could be found, some wrong ways of thinking and wrong conclusions of the past can also be cleared up here.

The blueprint logic, which our brain is subject to, is neither genetically nor by origin or socially shaped. This concerns exclusively the perception, genetic influences determine e.g. how well developed sensors or actuators (eyes, ears, limbs) are, but not the logicitself. This is identical in every life. It can only be that due to perception or defective areas, which may not even be present, a living being cannot communicate.

■ The brain is a single "communication and command machine", i.e. the underlying blueprint logic ensures that new pathways (synapses) are formed according to the perception and, in the case of multiple rapid requests, cells.





Dignity - consciousness is an actuator

■ This represents paths, that means a perception after abstraction takes different paths and contacts within this many cells and nodes. If these in turn are directly connected to actuators, for example, or if actuators are integrated on the path, these become active.

One of the actuators is also our consciousness. Everything that cannot be processed directly via the subconscious is sent to the consciousness as an emotion or feeling.

■ The feeling/emotion is a kind of matrix, which contains the momentary perception as well as the possible ways. The consciousness can now move in this matrix. The locomotion is thereby for the subconscious the order, how in the future is to be acted. I.e. the subconscious creates new connections.

■ The evaluation of an emotion or feeling depends on whether there is a path within the matrix that leads to a desired result or in the past this situation has always led to an undesired, i.e. bad, result.

■ This procedure makes it possible to bring about very complex and far-reaching logical changes with single decisions, with small changes of order. The brain may only have to insert a cell or a new path for this.





Dignity - The human being is constantly changing

■ I.e. a human being with his Blueprint logic is highly flexible and adaptable. It is possible at any time to make new complex changes through it within a very short time and to create new areas in the brain.

■ No human being is as he was born, no human being today as he was yesterday. The perception changes automatically through the functioning of the blueprint logic the brain, we can not prevent that at all.

All the more we have to use our understanding in the future to pay attention to what we perceive, whether it is ok or not and to calibrate our environment accordingly, that only correct logical processes should be fed to us, otherwise our blueprint logic automatically builds wrong, undesirable connections and paths. This becomes now in the future the endeavor of humans, because only by this there can be a good future.





Dignity - our will controls us

The will – the result of the control of our self – a circle reference.

Humans can neither consciously describe how in their brain which cells actually focus the eye, how this comes about, how actuators are then controlled with which nerves, nor how the action of grasping the cup comes about physically at all.

■ We just have to think "I want a drink now" and we drink. Most of the time we don't even have to think about drinking, because we do it automatically while thinking about other things.

Only when there is nothing to drink in a situation do we get thirsty and only then will we consciously think about drinking at all. So our will to drink something is nothing more than accessing a certain existing logic that is stored in our brain – i.e. understood – and thus our brain can handle it flawlessly and lead to an actual successful action.

Understood correctly, this means our brain – the Blueprint logic – has several functions. On the one hand, it processes everything that is perceived. For this, it uses unconsciously, without us having any influence on it, an abstraction procedure.





Dignity - the action as an expression

■ Influence we have consciously only partially, this by the fact that we express what we perceive, so that other people understand it and can repeat the whole to us. (There are other methods, read the book "Consciousness").

■ With it existing abstraction tables, i.e. sequences are differentiated in it (the behavioral sequencing), this differentiation creates conscious entrypoints or connections in our brain, over which we can use on the one hand consciously these after our will, in order to interpret new actions or perceptions differently. On the other hand, these differentiations represent our competence in how finely and "sensitively" we can perceive things and consciously deal with them.

Actions – the procedure

The same principle applies to actions, i.e. in movements, for example, the individual movements are named more precisely, i.e. differentiated, so that they can be practiced optimally. This is the adaptation process. Thus, based on the Blueprint logic, our brain is the connection and control of our body in the environment, our consciousness exclusively our training and success concept.





Dignity – the importance of emotions

Emotions

Emotions and feelings, a fund of assumptions and interpretations. Until today, no human being has been able to explain emotions comprehensively, some consider them important and so significant that following them constitutes life, others consider them unimportant or even dangerous, so that they should be suppressed.

As long as we do not understand the function of emotions, understanding is not possible and everything is right or wrong. In the past, studies that scanned the brain (using FMRI and other techniques) tried to explain emotions. However, these explanations ended in determining where to pin down and find them in the brain. Other studies looked at how emotions can be retrieved and what effects they can produce. But this is far from an understanding of emotions.

The research of the axioms as well as the research of the Blueprint Logic can now give enlightenment. (Read the book "Emotion"). An emotion is therefore a communication package.

Our consciousness is exclusively able to see a moment, this can be a context or a logic. Like in a movie, we can then run back and forth, additionally run in different further directions like in a matrix.




Dignity – emotions and subconscious

■ While we are doing this, our emotions and feelings are also constantly changing – unless we are desperately trying to resolve an unsolvable situation. Here, nothing changes except that we always feel pressure and unstoppability, a kind of depression. This is a so-called unsolvable vicious circle, i.e. the thought always ends at the same point, no matter which way we have gone, the same result undesired by us always comes out.

This going through a matrix is the sense of our thinking, because if necessary an action comes about during the going through and we can dissolve the thought by it.

At this moment in the subconscious mind the situation has been transferred into a new situation with a new process or process that has already been carried out. Or we simply end the thought by "drop-

ping" it – this dropping takes over our Blueprint Logic in the differentiation table of perception and this is expanded from now on.

From now on we have the possibilities to react in situations according to it and we can get used to it. Whereas habit means that little by little the connections that have been valid up to now become obsolete by the fact that they are used less, the cells that are no longer used are not renewed at some point, but new cells and connections are created.

The more often we consciously use these differentiations, the new cells and connections are created, at some point when this is all physically created in the brain, it means it has passed into the subconscious and it does not require thought nor does it evoke a certain feeling.





Dignity - one by one

Emotions – our matrix of consciousness

In the reality and perception as well as within our brain all things are connected with each other in interaction, as well as in temporal result. The reality is an interaction, the momentary situation because of the interaction of the situation before, the following situation because of the interaction within the present situation.

Since in every situation not only one factor but many things interact with each other, but we can

consciously only concentrate on one factor, one thing and how to deal with it, i.e. we cannot think through 2 different things at the same time, we are forced to look at only the logical connection between 2 different things at a time and let a kind of movie run.

■ If we do not like the "results", we can play back the film, i.e. let the consciousness do it virtually again differently and check the results of this action and interaction.





Dignity - everything must be solved

This until either we have gone through everything and decide on some path that we now act, or we end up in a deadloop and desperately try to find something that leads to a different result. We noticethis desperation as pressure or bad feeling.

■ That is, wherever we cannot find and assign an action that gives us a result that we perceive as good, we get a bad emotion.

■ In the case of results that we perceive as good, we get a good emotion. Accordingly, emotions are nothing more than a multi-dimensional stream provided by our subconscious mind, which we can consciously run through and make assignments to the situation and our action.

The better we can deal with a situation, the less we get a bad feeling, but we classify it as good.

■ However, this does not mean that it has to be really good, because it may be that the action harms us later, but we acted out of lack of understanding. A small child likes fire it has understanding, so it may set fire to everything or burn itself.





Dignity - emotions are individual

Emotions - good or bad, no meaning as long as understanding is missing

The evaluation of emotions, whether we classify them as good or bad, is an individual evaluation based on a verification that is made.

■ Narcissists or psychopaths have learned, since no one has verified the results with them exclusively themselves, they have accordingly not created any connections in the Blueprint logic that are related to Integrity or Economy with other people. ■ That is, these can kill someone without any bad conscience – that is, without any bad emotion – and have a good feeling, or take everything from someone and have a good feeling.

■ I.e. the understanding of life must be present in order to be able to evaluate emotions correctly at all.





Dignity -opinions are not statements verified with nature and life

Opinion

An opinion that cannot be verified, i.e. for which there is no clearly conclusive logic (circular reasoning), i.e. the exact understanding of it cannot be reproduced, but is regarded as fact, is the expression of lack of understanding and stupidity. Such an opinion reflects that the person wants something without knowing why, why, why and what it means for others or how others are influenced with it.

An opinion is thus a means of giving other people a perception that may be very harmful.

It is a way to manipulate others Blueprint logic through perception and lead these people to a false conclusion. ■ It is not reasonable for people in any way and incomprehensible at all, why an opinion, which cannot find a way to the good in any way, because it does not fit logically into the overall situation (because there is no concluding logic), may be announced. An assumption or an expression of will does not have this negative character.

Illogical opinions do not make sense and harm humans very much, because the Blueprint logic has perceived this very well and will include this logic in the future, as long as the opinion is not revoked. We are seriously harming ourselves humans with this approach.





Dignity - the treatment of oneself

Consciousness - Steeringresponsibly

Dealing responsibly with something is only possible if an understanding for this is given. I.e. in order to deal responsibly with life, the understanding for life is accordingly necessary. If I do not have this understanding, I end up very quickly in incomprehensible acting and thinking.

■ Our thinking, our consciousness, is our "console" to program us as a human being, to decide how to deal with oneself. There is only the how to deal with yourself, the environment is namely the own environment, the own action determines the interaction of others, that is basic law. ■ If I deal with myself wrongly, I will also deal with the environment wrongly, there will be quarrels, war and environmental violations, thus my environment will automatically be damaged, my life will be damaged, even if I should have been the stronger one.

■ Through war and strife, in fact, a further and further restriction happens – the increasing inability to deal with myself and others. My identity dwindles more and more, my abilities dwindle. Survival is only possible for a while, it would be in principle a mercy, if someone else would then put an end to my life, I could then no longer cause further harm to myself and others.





Dignity - intelligence and incomprehension

The logic of the will and its limitations - the identity of the human being

The Blueprint logic, our brain, works completely logically, it works without intervention, we cannot control the functioning of it consciously or unconsciously at all.

■ I.e. the "intelligence" which we like to imagine is nothing more than the actual lack of understanding towards ourselves and our function, i.e. misacceptance of us – and if we have that against ourselves, then also against any other life. Therefore the significance of the sentence: "In order to be able to deal with something with understanding, one needs an understanding about it".

■ Please do not be angry with yourself now if you have been proud of your intelligence and knowledge all your life and now you are shown that this represented your inability to understand and explain yourself and thus others. It was like this until now for every person who did not know BCOL and Blueprint Logic.





Dignity - the earth is not flat

■ This was also so similarly with the people in the Middle Ages who thought the earth for a disk and therefore forced not to go far away from their place because they would have fallen down from the disk otherwise. This means a person in the Middle Ages usually did not have the will to go too far away from his place, because a stored logic that one could fall down from the earth had not permitted this.

■ This logic, today we know it was wrong, had accordingly severely limited people at that time. They did not have the understanding of their environment and accordingly they could not deal with it with understanding, recognize and live out their identity. In conclusion, this makes sense. In order to be able to deal with something with understanding, I need the understanding.

■ In the Middle Ages just that of the earth and that the earth is a kind of sphere, up to now the understanding of the human being about his own thinking, feeling and acting. The conclusion from it: my abilities, competences, my will is accordingly dependent on the understanding about myself.





Dignity - the will to interact with the environment

■ The will, the conscious ness, the understanding It can be stated, only what I have understood and can also consciously express, in action or description, I can also consciously want.

■ The will is therefore an experience, an understanding of me and my environment. What I want is accordingly a result of my past experience and changes, depending also with new perception.

• We can observe this with a toddler, if he sees a lolly (or toy) in the grocery store, he would like to have it.

If it does not get this, it tries with all means to get this.

■ However, if you give the toddler a distraction – i.e. a new perception, it can be very quick that he follows this perception, because this one was nicer for the child, and suddenly wants the new one.

So then you give the child a nicer bigger lolly, it no longer wants the previously so hotly desired.





Dignity - will as a result of understanding

■ The will – as long as it is not shaped by a full understanding and thereby resulting perception for life, but from a situation without comprehensive understanding – is quickly changeable and accordingly for one's own life as well as that of others not particularly authoritative, under certain circumstances also very harmful and not at all reliable.

Concluding, then, will is nothing more than a result of understanding that comes about because of perception and the logic of the whole. ■ The better people can understand themselves, others and the environment, the better they can build up a firm will for successful living, in which the individual situations then hardly play a role and they master hurdle after hurdle almost unconsciously, since the logic of the action is increasingly controlled by the subconscious.

■ However, the understanding of the axioms, described in "the secret of life", the understanding of oneself, described in "identity" and finally the acceptance to want to live this is absolutely necessary.





Dignity - effect of life

Life is: every situation is the starting point of the next one

Life is a constant dealing with oneself, dealing with the environment, understanding oneself and others (to be read in "Identity").

■ The understanding about time, that life does not have a moment, but life has the task, the identity, whose causal effect, meaning, and purpose it is, in recognition of the life of oneself as all others, in the same identity, on the same world, to make this possible for every life and of course without restrictions

■ Because if I restrict other life (its identity) in my life, this automatically has the effect of restricting my own ability to live in thought, my will changes accordingly and I will no longer be able to be open to life in general. This is a basis for life in dignity and this for every human being.





Dignity - high quality treatment of oneself and one's environment

Me, my identity, my dignity, my life

The word "dignity" has not yet been described precisely, because there was no way to precisely define dignity in terms of actions and processes.

Dignified handling means handling in the sense of how something should be used in a high-quality manner.

■ For life, however, this means that it would be necessary to have the understanding of what life is. How does life work, how is it used, and how does one ultimately deal with it? Due to a lack of understanding of life, space and time, as well as how a person achieves understanding in the first place, dignity could not be adequately defined until now.

■ The discovery of the basic axioms of existence as well as the description of these in their infinitely continuous operation (cf. 9 books) has led to the understanding of the handling of nature as well as the understanding of autonomous organisms (life) to describe exactly as well as to integrate comprehensibly into technology (cf. "the secret of existence", Technologies), to define uniformly the environmental parameters which life needs to be able to live at all and to be able to calculate logically as well as mathematically (in Economy). Please read the book "Social/Integrity".

Every life needs an appropriate environment, space and time, in order to be able to live with dignity, i.e. with understanding, and to be able to perceive and understand things.





Dignity - the nature of life

■ From the understanding of the axioms (BCOL) a general principle for life can be derived:

■ The nature of life is to use the capabilities given by nature to the fullest extent to sustain life as well as the habitat, thus protecting every life.

Conversely, this means that every life needs a habitat that allows life to use its abilities and to fulfill allits basic needs.

■ This applies to every life, is basic identity, regardless of skin color, origin, etc., and every life has to work to ensure that this can be observed. To implement and observe this self-evident fact is called accepting the dignity of man.
