Social - together and capable of action

■ Us humans commonly measure ourselves by our social attributes, one perhaps a little more, one a little less. In fact, "social" seems to define a basis of human coexistence. But what is really social? There is still no agreement on this, although it would be important, on the one hand for our own selfdefinition, on the other hand for the definition of society.

■ Social – the areas make namely that, how our life runs, which possibilities we and other people have,

how school education functions, the disease system and also taxes. But the tragic thing is that because the meaning and life of man could not be defined exactly until 2021, the term social could neverbedefined correctly.

Read now how due to the work of LON- science (Logical Operational Natural Mechanics) and its decoding of life, understanding and thinking can be socially defined. You will get a new picture of life, yourself and other people.





Social -together and capable of action

The social measurability

I am helpful and social, we are social. What does that actually mean? Is there a measure of social?

People can stay away from me

I do not need a person, either you do as I want or you can stay stolen from me. Each person should live as he likes, only he must not disturb me. Everyone his faith, as long as this does not concern me. There are many ways of life, I live mine and to whom that does not fit.... – There is a living space, an atmosphere a nature people share this and people need people?

The definition of social

In the past, "social" had many different meanings and could not be defined precisely. One calls it social when a person is allowed to end his or her own life, the other when one helpfully donates something from one's assets. The interpretation of "social" ranges from "common" to "capable of action". Aprecise definition has not yet been possible.







In 2020/21, presumably no one could claim to have never encountered the terms "social" and "human dignity".

However, these concepts were completely misunderstood until then and for many people factually meaningless, anti-social conditions prevailed in the worldasneverbefore.

On the one hand, there were technologies and possibilities that would have made it possible, without really taking anything away from anyone, that all people could have lived in dignity, that the living space could have been shared. A common ability to act could therefore have been achieved. Mankind also had more money and assets than ever before.





On the other hand, immeasurable suffering and misery could be observed all over the world. The following figures are known: There were about 82 million refugees due to wars, about 30 million people died of hunger, 155 million people suffered from starvation, and 745 million people lived in extreme poverty, there were natural disasters and storm damage like never before in living memory. The number of mentally ill people reached record levels, as did drug use. There is no animal species known on earth that lives under such anti-social conditions as humans.

A general operational order is missing, which functions in such a way that a life worthy of man beco-mespossible for all.





Social – Without logical definition every belief or opinion is correct

Alogical definition requires understanding

Due to the fact that the meaning of life as well as the mission of life could be pronounced only since the discovery of BCOL, it is possible at all to specify "social" – we use the term Integrity – exactly. In any case, "social" has something to do with autonomous living beings, such as we humans are. A possible interpretation of "social" could be "capable of acting together".

Together

But what does common mean in this context, and what does capable of action mean? To understand this, we must first understand the human being as an autonomous life, in its nature, the basic needs. Together can have many meanings, for example, do we all need the same house, or do we all need the same food. So this is again interpretable in any direction or opinion. Everyone believes then again in something what he means, which would have to be right. That is certainly not social, but automatically again anti-social. Anti-social means, everyone like he thinks. That leads automatically in a sameliving space to misunderstandings and disorder.

Capacitytoact

Also ability to act is a term, which could not be defined among humans so far generally validly. This due to the fact that man and his nature could not be defined flawlessly. Again there were many opinions and beliefs. Simple was then to say, everyone is individual, there is neither man nor woman, we know only human. In the social thinking this led to it, we give to everyone a basic security or a basic income, with it he can live then. Again, only when the understanding of life is given, can we determine what means capable of action. With animals, if we keep them in an enclosure, the opinion is often held that this would not be correct, the animals would die, even if they get food. This because they are not capable of acting. For humans we have so far omitted this logic. A schizophrenic aspect of the social policy, which carries perfidious features.





1. Understand nature Nature – the basis and producer of life and the living space





Social – How do you capture "social"?

The foundation – our understanding of nature & life

As long as we have not understood the nature and the nature of human life, it is logically nonsense to want to claim that one knows what social is. This can have been so far only an assumption, on the basis of the own experience, perception and logic, however, not in the remotest way as fact or generally valid to be regarded. At most, that the majority agrees with this point of view, which again is no proof of a fact. It only means that the majority perceives it that way, even though it may be completelywrong. The past showed many such episodes.

Quantitative measurability

The whole thing becomes even more perfidious when it is tried to make the term "social" look like a fact or truth with quantitative measuring methods. This speaks of a complete misunderstanding and misperception of nature. Life means that it happens over time and is not owed to a moment. It is therefore a sequence of events, I am living. Socially, therefore, since it is about life and life possibilities ,can never be measured quantitatively in a moment, or by a quantitative method over time. Life is always a process of time and the ability to act, this is one of the most important quality characteristics of life. Accordingly, "social" must be expressed qualitatively.





Social - logic and nature

■The quality

Quality is the characteristic that something with appropriate use and care over time permanently fulfills its purpose within this time completely, without being subject to appropriate wear or defect. In the case of an autonomous living being such as a human being, this would mean that one would first have to know what the purpose of the human being, i.e. the meaning of life, is and also one would have to know what is the use, what is the care. Without these understandings, therefore, neither quality nor conditions can be formulated. However, this was not possible until now due to the lack of understanding. The discovery of BCOL makes this possible.

Understanding nature & the basis of life

BCOL – balanced cooperative operational logic – describes how everything in our existence works,

the operation of our nature, in a logical, always the same interaction. With this, every situation can be explained and made comprehensible. BCOL describes the interaction of objects as well as the communication, the thereby occurring interactions, thus also quite clearly the operation of our nature as well as our habitat.

The operation & function of nature

BCOL gives the understanding that no matter what we do there is always an interaction with other objects and this represents a change in the habitat. It describes the cycle and interactions of nature (read the book "Habitat and Nature") and explains the relationships of the physical law of conservation of energy as well as the process of entropy described in the principles of thermodynamics.





Social – interaction in the habitat

The basis of capacity to act

Cooperative expresses that all objects, all interactions in our existence and habitat always have influence and interactively influence each other. Balanced stands for the fact that the influence takes place exactly balanced to the relation of the onetotheotherobject.

This is imaginable e.g. in the fact that a drop of water falls into a lake, cooperatively the water molecules lying around make place for the one drop, this results in a circular wave which continues its elfever further and becomes weaker sometime, i.e. the whole balances itself over all available water molecules. At some point, you no longer see any wave at all, because there is only very little displacement.

Cooperative capacity to act

This is the basis of our nature, that everything is "cooperative" and "balanced". The reliability of this logic makes existence and life possible, is the basis of everything. That means, it is the basis for a habitat and nature to exist at all.





Social – One for all and all for one

Afoolishewhothinks everyone as hethinks If certain water molecules were not willing to cooperate, to interact in their relationship, then we would no longer have liquid water. Because the molecules would refuse to change their place, their place. Our blood could no longer flow, plants and trees could no longer feed themselves. Life would no longer be possible. The universe would no longer be possible.

Afool is he who thinks that each individually

If the molecules were not ready to cooperate "balanced", to interact, then the drop would cause an elevation in the water, water would run up the hill or simply fly away, because it would not be balanced to other objects and molecules, a pure chaos.

There is a basis – a functional order

BCOL is a logic of operation that describes all the interactions and interactions in our existence. Everything we know acts exactly in this way and only on this basis an existence and an order is possible. Through the operation according to BCOL a habitat could come into being. As soon as nature would oppose this or every organism would do what it thinks, then disorder and chaos would arise, any ability to act would be lost. The existence fights itself then, nothing goes any more.





Social – logic and existence

■ BCOL, the operation of nature – the security BCOL thus describes interactions, the perpetual change, that nature due to its natural operation is in a process of constant change, that there can be no standstill, since everything interacts with each other balanced cooperative, thus the present situation is the starting point of the next and this endlessly. The process of order creates as a result the habitat.

AClearOrderandOperation

The existence is subject to a clearly ordered procedure which every object is subject to and follows. The appearance perceptible for us may be disorderly, it also changes constantly due to the interactions, but these changes are the possibility for existence to be permanently possible and a habitat for life to have come into being. We can rely on water behaving like water, light behaving like light, sounds behaving like sounds, etc. A reliable operational order, i.e. reliable temporal processes.

Basis of existence, diversity & individuality With this order it was possible that the existence originated from the "nothing" (whether one calls this as "nothing", as "God" or completely differently, is irrelevant), that everything spreads interacting with each other, the universe, the nature forms itself balanced cooperative, the earth with its habitat originated, the nature created the life, exactly using this order according to BCOL, the life created again a brain, based on this logic, and thus understanding autonomous life originated. Life can keep the order within this order and on basis of

the order individually interacting.





Social – individuality is always balanced

Individuality due to operational order

First developed plants and animals that balanced themselves. Then the human being with special abilities due to his physique, e.g. to develop tools and skills to adapt the habitat to his needs and to learntounderstand.

Understanding is the basis for operational order

The discovery or manifestation of the BCOL has been now the last step to explain the nature, the universe and its function fundamentally and to make it possible to be able to explain and to work out every situation to enable life on the basis of the nature-given order to protect itself like the habitat.

BCOL has thus precisely defined the nature of life and the task or meaning of life:

• The nature of life is to live, to fully use the given abilities as well as the understanding given by nature, in order to protect life, one's own life and thus also all other life, such as the natural habitat with all means.





2. Understand life The nature of life the basis for life and quality





Social – laws restrict

The basis

On the basis of this basic law, the basic operation, now "social" or Integrity can be explained and derived perfectly. Only if we have done this successfully, we know at all what life, the existence of life actually needs. Life is, as noticed in the meantime, no object, which one cleans and makes clean, then it is maintained. Life is autonomous, in a living space, i.e. it has requirements in the course of togetherness, i.e. in the "social". These must be understood as described in the chapter "Understanding" on the basis of an operative order.

Operation – The function of something

Operation means, something functions and works. A function is to be understood thereby in the fundamental difference to a law. A law is a restriction of a function. Up to now we humans knew best with laws when it was about our life, however, much too little with functions and processes, although life is always and quite naturally a process.

Unknown function or operation

This already alone because we were not able to define the function or operation – neither that of nature nor that of man – or to express it within an operative logically inferable logic. It was not known until the discovery of BCOL how to express an autonomous function or even the order of nature. For certain areas we could express a regularity, so e.g. the gravity or the law of conservation of energy, but we were not able until then to define why energy is not lost, which function or operation is behind it.





Social – only works with a space of freedom

Laws restrict possible functions

Because of this, we had to pass laws to limit the operations or the functions that an autonomous life could perform. This compulsorily, because otherwise only the power of the stronger would have been valid at this moment, therefore a continuous disorganized anti-social behavior. However, we could not determine, how does a social behavior look like, also not why anti-social behavior is just as harmful for the stronger one. There was just no understanding how life and nature works.

Noquality without understanding

Quality and intrinsic value are interrelated. As already mentioned, quality is a functional timerelated characteristic. This means that the function of something is possible without restrictions over a certain period of time if it is handled and cared for correctly. If now neither the function nor the "care" is known, then the quality characteristic of the object is very questionable. Only the understanding of the function and care, i.e. the necessary attention, enables a definition and statement about quality.

Controlled operation, function

To be able to speak of function or operation, the criterion is that an object interacts within time. And if it is only simple functions, like a table. We know more complex functions from machines that perform complex processes under computer control. Al-controlled robots can perceive change in a quantitatively defined environment and interact with it in a differentiated manner within their regulated spectrum. They do this by developing their own new rules within the spectrum assigned to them on the basis of sensors and their data and by working on the basis of these rules.





Social – autonomous life is logical

Sets of rules as the basis of life

However, the basis was always a set of rules. Due to the expansion of machines, countless new sets of rules emerged that could neither be traced back to an order or a uniform understanding, nor was it possible to bring them into harmony with each other. With homogeneity opposite humans and nature this had nothing to do for a long time any more. The people had to follow however inevitably, most did not notice this at all, these sets of rules, since the life was made possible only by these. However, since no other understanding was available, this was finally the way with which one thought one could become successful and protect the life like nature.

Autonomous life is operation based on nature

Autonomous life means interacting every moment, the heart beats, the brain works. Even when we sleep. This is a characteristic of autonomous life. Autonomous life is not subject to any set of rules, like nature. It simply uses all the capabilities that nature provides to operate. As well as nature. By the operation of nature, corresponding possibilities or impossibilities arise naturally within nature, its cycle. Now these can be expressed operatively: one can do that. Or one can express them lawfully: one must do so or not do otherwise, thus restrictively.

Operational logics - their effect was well known

Operational logics were dealt with every day until the discovery of BCOL, but they were not logically defined and one could not yet bring them into a generally valid context, i.e. an understanding. In physics, for example, the law of conservation of energy, whose perception is based on an operative cycle, as well as the disorder number entropy and the corresponding thermodynamic law. However, only the constraint could be described, but not the operation of the system. Therefore, until the discovery of BCOL, there were different laws of nature. But only one nature.





Social – people, animals and nature

Autonom operational

Autonomous life like animals and humans show by their autonomous behavior, i.e. by the fact that they are able to interact with the habitat in various ways, that there must be something that enables them to deal operationally with nature. Babies, for example, cannot walk or see correctly when they come into the world. They only start to explore their habitat, to play with it – i.e. to interact – until they can predict quite well what the result of an interaction will be. They do not follow any rule, but use the natural operation in interaction with their own.

Autonomous operational – without any rule

This means that an autonomous life knows no rules, it uses the possibilities of the living space. Whyshouldituserulesthatrestrictautonomy?The merethoughtofrulesdoesnotallowautonomy.

The operation of nature is their livelihood.

With animals it is to be seen very well, their rule is the life, most of the animals have neither school education nor street signs or a basic law and nevertheless you live mostly in social packs together, you use nature, in order to ensure their own life. Many animals like wolves, ants, bees or even dolphins have a complex operating principle. This has been working for thousands of years.

Autonomouslife of the human

Now one could get the idea that humans with their thinking, feeling and acting would be much more complex and also more intelligent than animals are. This is a fundamental error, superstition, which originates from the time when BCOL and the operational logic, which is responsible for autonomy – the "blueprint logic" – were not yet known. Humans depend on the habitat of nature and share it just like any other living being. Perhaps if one takes now wars or the failure the permanent against each other like the destruction of the own habitat, then one can say, no animal has been so on it to weaken itself and/or its kind so and to go against it like the human being. Does it fit to call this intelligent?





Social – understanding enables coexistence

Here it is confirmed: No quality without understanding

In fact, the behavior is based on a misunderstanding, that of the laws. An autonomous life can be bound to laws only limited, this as long as the possibilities of the interactions are described exactly. No more if these possibilities grow, because then a law would have to exist for everything new. This does not work. There must be an understanding for the operation of autonomous beings, with which one can show the possibilities of these.

The cavemen had this division

With the cavemen it was still clear how the autonomy was used: a division of tasks, the responsibilities were structured and thus a life was possible. Everyone according to his abilities, completely individually. Every advanced civilization then started at some point to restrict, not based on abilities, like the cavemen or in the animal kingdom, but based on skin color birthright etc.. Then forms of state were developed, socialism, democracy, dictatorship, etc. It was always the attempt to achieve a "social" functional community.

The understanding of autonomy

None of the forms has been able to survive in the long term. Either man and his autonomy was bound to money, then destroyed the habitat, or to some other rule. The problem was that man was not able to find an understanding for himself, that is life and his habitat. This is now fundamentally different since the discovery of BCOL, it will be seen whether man still manages to preserve himself and his habitat, or whether it is already too late in the meantime.





Social – Future only works with nature

BCOL changes the foundations of understanding BCOL is not limiting but opening, following nature and its operation, is an operational logic given as a birthright to animals as well as to any other autonomous being. This operational adaptive logic "blueprint" acts due to perception of the logical interactions of nature, it is the "cause" of a baby being born without understanding of nature and yet after some time being able to deal with nature and environment.

Blueprint logic - the understanding of autonomy Thus, operational blueprint logic is the understanding of how autonomous life comes about, understands it, and interacts with the habitat. The key to this is that we humans can now finally define our nature and meaning of life logically and thus discard the rules of law and interact with understanding towards ourselves and thus towards other life. Because nature works cooperative balanced, so does the Blueprint logic. The only thing that has not been cooperatively balanced so far has been the opinions and the illogics due to the prevailing lack of understanding of nature.

Understanding means that an organism can comprehend and execute a process and ist order.

■The understanding - the basis of future

This understanding provides the basis for a highquality future. The question is now whether we humans successively replace the faulty opinions and beliefs with new high-quality operational procedures, thus enabling us to live a high-quality life or not. All who have worked on these elaborations would wish for themselves and for all other life (quite egoistically) that we humans get this implemented.





3. Social / Integrity Basics of togetherness





Social – foundation and necessity of life

The operation and explanations

The following is an explanation of how BCOL functions within autonomous life. Through this, the term "social" can then also be defined logically. Now surely every reader is already aware that "social" will get a completely different, new meaning. It is certain in the meantime that "social" represents a basis of life, which has nothing to do with other people, but is valid for every life in the same way, thus is actually universally necessary for survival. If you now read on, you will understand this.

The skills and necessities of life

Since the existence, the nature and our habitat is based on a reliable logical functioning, this is therefore the basis of existence and the habitat, it follows that life arose, which in turn adapts the same reliable logic to live. Autonomous organisms use this logical functioning complementarily in the brain as blueprint logic. That means that we are a logical image of nature, using its functioning or operational order to be able to live.





Social – Respect nature and the body

Disregarding nature

Therefore, any action that we do not act in a balanced cooperative way in harmony with everything that surrounds us, is nature-changing against nature, thus against ourselves and life (see the chapter "Nature and Habitat" as well as the description of the technologies).

Lackofunderstandingofthebody

This is easy to understand with a visible example. Our body needs space in the habitat in order to be able to develop. It needs food, water etc. This is given by nature in such a way, with it compellingly to keep, otherwise the body survives only for a certain time and then dies. But also this must be balanced. If too much food or energy is supplied, the functioning is impaired, the body takes in more energy than it gives off, this is neither cooperative norbalanced.

Understanding the entirety

With the body, we now understand some of the processes. In the near future, BCOL can also be used to explain and describe the other processes, the functioning of cells, genetics, and so on. Thereby, if you express the whole thing not in rules but in operative logic, there is only little to understand, because these operative logics are implemented by the brain within fractions of a second. Read for this the books "Understanding" and "Consciousness".





Social – the power of understanding

Social means living yourself and your life in a quality way

Socially (or Integrity) can mean therefore only that a life behaves balanced cooperative opposite itself, thus its body, opposite nature and the social environment. This is not because there is a compulsion to do so, but because basically the body comes to harm if the BCOL is violated or disregarded and this would be directed against nature, thus also against one's own nature. If one does not pay attention to his own life, then one acts accordingly already anti-social. How will one then only act towards other life and the habitat?

The autonomy, the understanding

So far, we have not been able to identify the nature of man. Everything we do not know, we try to explain with something. Our brain always needs a closed logical circuit for everything, the explanation. If one does not have this, then one assumes. Up to the discovery and manifestation of the BCOL therewas also no possibility to be able to prove and prove something exactly definitely logically. Therefore one had beliefs or empirical scientific statements which one considered as true until they were disproved by something else.

Identify incomprehension

Instead of classifying something incomprehensible as "not resolved" or "we don't know that", opinions and assumptions have been manifested. Since the brain logically converts what it perceives due to its operation, these opinions and assumptions were perceived and confirmed by the brain. Thus, in the people who have classified these opinions as confirmed, this perception has been used by their brain to adjust the actions to this perception. This is an automatism due to the operation of the nature (and therefore of the brain).





Social – our understanding builds the brain

The "comprehension bubbles"

Thus the consciousness of these people was separated from the operation of the BCOL. Man builds his own virtual world with it, independently of the real tangible nature. He is no longer able to see the natural processes in their order. A disconnection from real life develops, a schizophrenia, a world of one's own, which exists virtually, but makes the person unable to survive in the long run. This also damages the communication with other people, because exactly these misinterpretations are passed on and other people also perceive and adapt this.

Faulty understanding - faulty perception

Our perception and our conscious thinking are the food for our brain, whose synapses physically and physiologically adapt the perceived logic on the basis of the perception by actually building up like this and thus manifesting the thinking in this form. (Described in "The secret" and "Intuition", "Understanding" and "Consciousness"). Although the brain is able to replace these connections by others without any problems if the human being is consciously willing, one has to be made aware of it first, because one does not become aware of it oneself, since one's own brain thinks exactly in this way.

BCOL - the solution

BCOL is the solution here as well, as it enables everyone to check and correct their thinking. BCOL is also adapted by the brain through intuitive training after a short time, thinking becomes clear and fast. There is now a technology that can adaptively train the independent with each person within a short time.





Social – Understanding shapes life

Autonomyandunderstandingisinnate

Until some time ago, people were actually still convinced of being particularly intelligent with a certain mission or due to their genetics, completely disregarding the fact that they were born like all other people without being able to speak a word or walk, let alone deal with mathematics. In fact, however, the ingenious ability to understand something has been put into their cradle by nature, like every other physically healthy person.

Opinion, erroneous belief limits life and autonomy and harms others.

It is crucial how many false perceptions a person has adapted in the brain during his life, which prevent him from understanding nature. This highlights the different levels of understanding among people. Fundamentally, the way the brain works is the same for everyone. Having 10% more or less brain mass doesn't really make a meaningful difference, because processing BCOL only takes up a few portions of our brain.

Individuality - the appearance

What is certain, however, is that the body, its specific training (large or small) influences physical abilities. One sees better, another hears better, one can run faster, one releases a little more adrenaline, the other less, and so on. Accordingly, certain areas of the brain have become more networked and specialized. These are then the individual strengths, but as long as the body of a person has no defects, it can be trained just like that of any other.





Social - the organization of the living space and the quality of togetherness

Organization – sharing a living space in an organizedway

Organization on the basis of operational order means that life uses the habitat together and everyone is a ware that his action is an interaction in the habitat and will influence all life in it. Organization therefore requires the awareness of being dependent on everyone observing BCOL in their actions. ■ Integrity, Economy, Functionality, Organization Briefly named "IEFO" is a logical operational procedure, which makes it possible to logically infer all operational possibilities and actions of people in real time via an appropriate technology. Thus, it is possible to act efficiently without harming other people, organized in harmony with nature. Under complete consideration of the individuality of the single life. For this, based on the Blueprint logic, a technology exists in the meantime, which can protect and advise humans (see "Technology").





Social – the right expression

■ IEFO - a holistic, logical - operational system Based on BCOL, as well as a corresponding logical technology based on it, a holistic procedure has been developed in the meantime, which takes into account the changes of nature as well as the individual autonomy of life and yet enables a complete organization "socially".

Integrity/"social" must correspond to the nature of the human being

Accordingly, following the nature of life, social (or integrity) can only mean to act according to life, to dojustice to its basis, functioning and operation.

Social - can be lived only qualitatively within time

Social is thus not a state, it means that action and thought are in accordance with the nature of life and the conditions that action is taken in accordance with nature without harming or causing harmtoone's ownlife or other life.

• Economy, habitat, condition for life
