### 2. The data protection officer of Ulm University

### 3. Purpose of the processing:

The photo and video recordings are used exclusively for matters of public relations of Ulm University as well as the above-mentioned foundations and associations.

### 4. Legal basis for the processing:

The processing of photos and videos (collection, storage and passing on to others) is carried out with the explicit consent of the data subject as per art. 6 para. 1 lit. a GDPR.

The publication of select data in (print) publications of Ulm University as well as on the University's website or social media networks is necessary for matters of public relations and thus serves the fulfilment of tasks of Ulm University in accordance with art. 6 para. 1 lit. e, para. 3 lit. b GDPR in conjunction with § 4 Federal State Data Protection Act Baden-Württemberg (LDSD Ba-Wü), in conjunction with § 2 para. 8 Federal State Higher Education Act Baden-Württemberg (LHG).

### 5. Recipients of personal data:

Within Ulm University the data are accessible only to persons who are in charge of public relations. This includes in particular department I-1 Marketing, Press and Public Relations and the Communication and Information Centre (*kiz*).

The data may be passed on to the University Foundation, the University Association, the University Medical Centre Ulm as well as media representatives and news portals or processors (publishers) for the purpose of publication.

### 6. Storage time of personal data:

Photos and video recordings are stored for the specific purpose for an indefinite period, or until the data subject withdraws their consent.

### 7. You have the following rights:

- a) The right of access to your stored personal data (art. 15 GDPR).
- b) Should incorrect personal data have been processed, you have the right to rectification (art. 16 GDPR).
- c) If the legal requirements are met, you may demand the erasure of the data, restriction of the processing as well as object to the processing (art. 17, 18, 21 GDPR).
- d) If you have given your consent to the data processing or entered a contract for data processing and the data processing is carried out by automated means, you may have the right to data portability (art. 20 GDPR).

You furthermore have the right to file a complaint with the supervisory authority for data protection regarding the processing of your personal data by Ulm University. Responsible supervisory authority is the State Commissioner for Data Protection and Freedom of Information Baden-Württemberg.
