Ulm University is not obliged to clarify the facts in an official investigation (*Amtsermittlungsverfahren*). Since we use only the documents you submit for checking your request, the principle of explanation applies. If these documents are not sufficient or relevant as evidence of your situation, we must unfortunately reject your request. Reference is made to § 10 (2) LHGebG.

Important notes and explanation of the application:

The request for a (partial) waiver alone does not affect the maturity of the tuition fees. It is still due in full within the deadlines for continuing studies (re-registration). Each request will be checked and decided individually. No future claims can be derived from this. This does not affect the timely payment of the semester fee (student services, student body and contribution to administrative costs).

With my signature I assure that, to the best of my knowledge, the information provided is complete and correct. I am aware that all information provided is the basis for a possible waiver of tuition fees and that I must notify any subsequent changes without delay. I am also aware that Ulm University may request further documents in case of indications of possibly incomplete or incorrect information.
