

# Statutes regulating the imposition of tuition fees in the non-consecutive master programmes "Advanced Materials", "Communications Technology", "Energy Science and Technology" und "Finance"

# of 18 March 2009

On the grounds of sections 2 paragraph 2 sentence 1, 13 paragraph 1 of the state law on tuition in higher education ("Landeshochschulgebührengesetz" = LHGebG) of 19 December 2005 (Federal Gazette of 27 December 2005 p 794 ff), changed by article 2 of the second law of the federalism reform of 03 December 2008 (Federal Gazette p 435 ff) the senate of Ulm University adopted the following statutes on 12 February 2009. The president approved the statutes pursuant to section 2 paragraph 2 sentence 2 LHGebG on 18 February 2009.

## Preliminary remarks on language use

According to Article 3 (2) Basic Law men and women have equal rights; all designations of persons and positions used in these regulations apply equally to men and women.

## Section 1 Compulsory tuition fees

Ulm University imposes tuition fees in the non-consecutive master programmes "Advanced Materials", "Communications Technology", "Energy Science and Technology" and "Finance". The imposition of fees, contributions to administrative costs, expenses and remunerations pursuant to section 1 paragraph 2, 12, 16,18 and section 19 LHGebG as well as contributions according to the student union act remain unaffected.

#### Section 2 Amount of fees and exemption from fees

- (1) The tuition fee shall be charged per semester. It amounts to €500 per semester or part thereof.
- (2) Periods of academic leave of absence are not subject to fees. The regulations of the admission and enrolment statutes of Ulm University apply to academic leaves of absence.
- (3) Students who are caring for and raising a child which is under fourteen years of age upon commencement of the respective semester be exempt from tuition fees.
- (4) Students who spend a semester at a university abroad shall be exempt from tuition fees.

#### Section 3 Compulsory tuition fees

Students applying for enrolment in the non-consecutive master programme are subject to tuition fees.

#### Section 4 Due date

The fee falls due when the tuition fee notice is issued.

#### Section 5 Refund

Should a student terminate their studies by withdrawing or changing their study course during the semester, the tuition fee shall be refunded as long as the lecture period has not yet started at the time of termination.

# Section 6 Payment in instalments, extension or remission of payment

On application and subject to section 59 paragraph 1 no. 1 and 3 of the state budget regulations (LHO), the university may grant payment in instalments or extension or remission of payment. Applications must be submitted before the beginning of the lecture period.

## Section 7 Effective date

These statutes shall take effect on the day after publication in the Official Announcements of Ulm University. They shall first apply to the summer semester of 2009.
